**Members' Card:**

1. The Members' card is your proof of Membership. Therefore it is **not transferable** and **should be carried at all times when accessing Club facilities.**
2. Members' discount will only be available for card transactions.
3. Transactions can only be made on a Member's account that is in credit.
4. To recharge a card's balance a minimum transaction of \$20 applies.
5. Cash withdrawals can only be made by application to the secretary/manager; normally in circumstances of terminating membership and only on relinquishing card.
6. Card replacement due to loss or damage will incur a re-issue charge of \$10.00.
7. Member's signature must appear on the access card.
8. Transaction record will require member's signature when circumstances are warranted, or on the Member's request.
9. Transaction statements can be obtained on application to the secretary/manager. The Club ensures the privacy of Members will be maintained.
10. Please treat this card with the care and security of any credit/debit card. Misuse may result in withdrawal of this privilege.
